Processing Guidelines

EL-Lene™ D777C is recommended to apply primer or corona treatment on substrate before coating for better adhesion. The actual processing condition depends on each machine type, size, and thickness. Generally, melt temperature should be around 300-330°C. Minimum air gap 150 mm is recommended.
